










WHAT DOES OUR MEMBERSHIP LOOK LIKE ACROSS CANADA (2021)







# FUTURE OF THE PROFESSION

### **MISSION STATEMENT:**

The Health and Safety profession has evolved significantly in the last two decades. Today, there are multiple initiatives across Canada and elsewhere in the world to redefine the roles and responsibilities of various players in the field, and potentially achieving professional recognition via title protection.

#### **Occupational Safety and Health**




Occupational safety and health is identified as the discipline dealing with the prevention of work-related injuries and diseases as well as the protection and promotion of the health of workers. It aims at the improvement of working conditions and environment. Members of many different professions (e.g. engineers, physicians, hygienists, nurses) contribute to "occupational safety, occupational health, occupational hygiene and improvement of the working environment" (p.22).


