Is there an opportunity for ACGIH to make a bigger deal of that position or educate regulatory bodies on that?

Phillip Rauscher, ACGIH – We are always open to have that conversation, spoke with OSHA last year about that, since we are advising hygienists with our opinion it is tempting to use that information, but that is terrifying to imagine someone picks that up and uses it as the new standard.

Ted Letourneau - The federal government references the ACGIH TLVs as their exposure limits directly
