#### CRBOH and IOHA supports ICOH statement on tuberculosis

ICOH former President, Prof. Jorma Rantanen, presented in June, the Joint Statement by the ICOH\*, IOHA and IEA on the WHO 13th General Programme of Work (GPW) 2019-2023 at the Seventy-first World Health Assembly (A71/1), Palais des Nations, Geneva, Switzerland. For inclusion of occupational health into the content of the



13th GPW, the ICOH, IOHA and IEA, jointly propose the following additional elements to the Programme: a) Extension of the WHO Global Plan of Action on Workers' Health through 2023 and inclusion to the Programme the development of specialised or basic occupational health services (including occupational hygiene and human factors/ergonomic design services) to cover all working people; the organized work life plus self-employed and informal workers in line with the WHO strategy on universal health coverage, UHC, and the UN Sustainable Development Goal No.3. b) Establish the WHO Global Programme for Prevention of Occupational Cancer and Elimination of Asbestos-related Diseases in line with the UN Resolution on Prevention of NCD and the related WHO Global Action Plan 2013-2020. c) Enhancement of the ILO/WHO Global Programme for the Elimination of Silicosis, including workplace actions to prevent tuberculosis among silica-exposed workers and among health workers, in line with UN and WHO for tuberculosis prevention efforts.

#### **CRBOH Remembers – Mad Hatters**





While the origin of using mercury to make better felt may be debatable, it is clear that by the mid-17th century mercuric nitrate, made by treating mercury with concentrated nitric acid, was being used to make felt, particularly for men's hats. Workers paid a heavy price, as hatting resulted in widespread cases of mercury poisoning. Psychiatric symptoms were common, as exemplified by the "Mad Hatter" in Lewis Carroll's Alice in Wonderland. Hatters' disease was not limited to Europe. In Danbury, Connecticut, the centre of the United States's hat making industry, workers often developed tremors and were said to suffer from the "Danbury shakes."

Mercury toxicity affecting hatters is a classic example of an occupational hazard, one that was eliminated in 1941 when the United States Public Health service finally banned the use of mercury in the felt industry. For more information on this subject:

## University of Regina / 2018 Report on Work Fatality and Injury Rates in Canada

On April 23, 2018 the University of Regina published the "2018 Report on Work Fatality and Injury Rates in Canada". This report, prepared by Dr. Sean Tucker, PhD and Anya Keefe, Msc., is a useful tool to assess the evolution of occupational fatality, injury and illnesses and to compare statistics of each province. Table 5 outlines the percentage change in Occupational Disease Rate (2016) compared to the average for 2013-2015 (per 100,000). The table

shows that larger Canadian provinces (Ontario, Quebec, BC, Alberta) have a relatively similar Occupational Disease fatality rate, varying from 3.6 to 3.9, but increases are shown when compared to the 2013-2015 rate. Provinces with smaller populations show a significant decrease in fatality, except for Saskatchewan, the Yukon and PEI. For more information please consult:
