- High bar for eligibility and maintenance

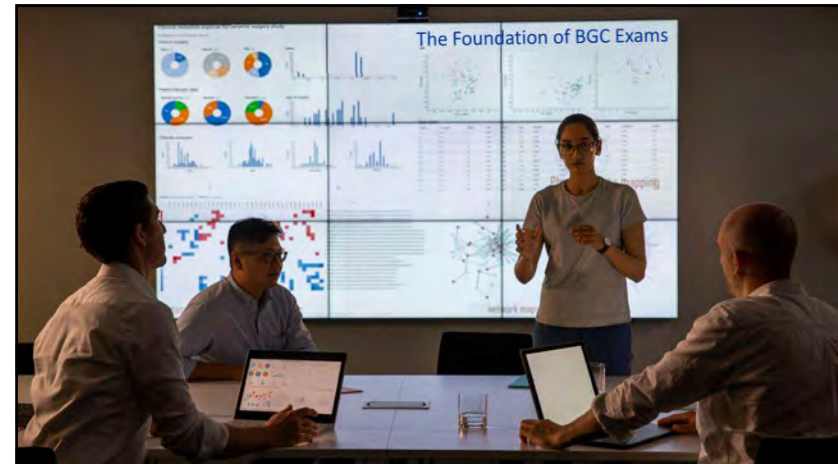
